Privacy Policy

The Sun Secret Collection takes the privacy of your personal information very seriously and has taken all measures in order to fully comply with the GDPR.

What data we collect

Booking Enquiry / Contact Form

When you make an enquiry on our website using either our Booking Enquiry Form, or our Contact Form, we collect the data that you submit in the form, as listed below:

- Name
- Email
- Telephone Number
- Country of Residence
- The IP address from which you submit your enquiry

We collect the information above for the sole purpose of communicating with you in relation to your request. We will communicate with you either by email or by telephone.

Booking with The Sun Secret Collection

When you make a booking in one of our villas, we require the following information, which we collect and store in order to prepare the necessary paperwork for your rental, as well as to optimally serve your booking:

- Name
- Address
- Country of Residence
- Date of Birth
- Telephone Number
- Email
- Passport Number
- Country issuing your Passport
- VAT Number (For residents of Greece only)

Storing your information

All information that we collect is stored in databases managed by third parties (our “Software Partners”) who are certified as GDPR-compliant. All information is stored in servers in the European Union.

Use and sharing of your Information

The Sun Secret Collection will only use your information with the purpose of conducting business with you and will never share your information with any third parties, except if you make a Booking with The Sun Secret Collection, in which case your information will be used as follows:

- We may share your information with the Property Owner of the Villa that you have booked for contractual purposes only (i.e. signing of the lease agreement) in accordance to international compliance rules.
- Your information may be shared with the local tax Authorities, where lease agreements are submitted, in accordance with the international compliance rules.
- Basic information (Name, Telephone Number, Email) may be shared with our trusted Service Providers (car rental companies, travel agencies, yacht chartering companies, aviation companies, etc.) with the purpose of optimum service delivery.
